- 2. <u>Team Fee</u>: We have a surplus in our ICL softball account above our normal operating reserve. The ICL Board has decided that the league should subsidize the team fee for a 4th year so the fee will be reduced to \$350 per team this year. (Largest expenses are umpire fees and fields)
